### AUTOCROSS

Dates for 2017 are set for September 16<sup>th</sup> and 17<sup>th</sup>. The club voted and approved 14 events (7 each day) with the purchase of 4 sanctions from St. Louis Corvette Club at the cost of \$50 per sanction (\$200 total).

I have presented the entire autocross budget to the Board and I'd like to entertain a motion from the floor to approve it for 2017. It is basically the same as the last couple years. The main difference is doing 14 events (instead of 12) purchasing 4 sanctions from STLCC instead of 2, and using the indoor restrooms at the Family Arena instead of porta-johns. Restrooms are at main entrance by box office and will be open to us from 7:00 am till 4:00 pm on Saturday and 7:00 am till 3:00 pm on Sunday. I will move the starting line area and food sales down closer to the main entrance. We still need to be off the lot by 4:00 pm on Saturday due to the scheduled MMA fight at the arena Saturday night. Bottom line is estimated income from autocross of \$2,600 if we get same number of entrants as last year, or \$1,600 based on a conservative estimate of only 44 entrants. This does NOT include food sales income.
